



**Covid-19 State UI Reference Guide**

Last Update: 8/31/2020

This guide will serve to assist you in referencing your state unemployment agency's progress in implementing UI provisions of the Federal CARES Act and FEMA Lost Wages Assistance Program. States vary as to how they are enacting new programs such as well as Covid-19 charge relief, UI fraud and return to work refusal. Please note many states are continuing to modify their regulations, rules and guidelines as the Covid-19 related claim volume continues to rise, so this information is subject to change.
